

## Beneficial Ownership Confirmation

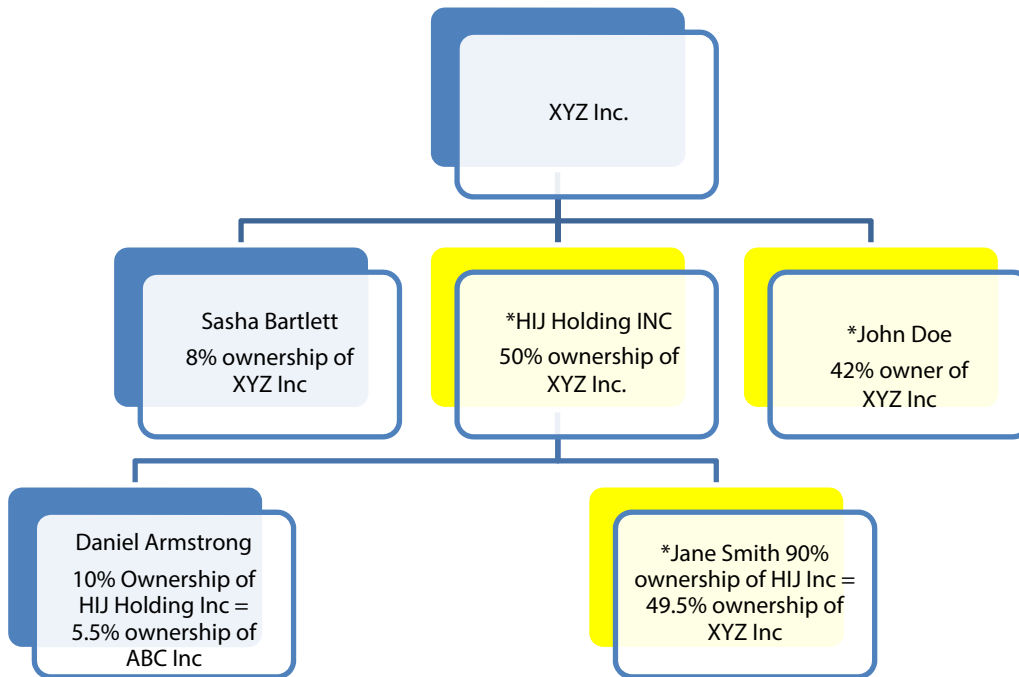
As a registered entity with FINTRAC (registration number M11619865) and Pursuant to the Proceeds of Crime (Money Laundering) and Terrorist Financing ACT which Payline Financial Inc. is obligated by law to follow, we require disclosure of beneficial owner(s) of the company. Beneficial Owners are individuals or entities who own or control 25% or more of the Company.

Example: XYZ Inc. where HIJ Holding Inc, Jane Smith and John Doe are considered beneficial owners.

The name, address and occupation/nature of business of all individuals/entities that directly own 25% or more of the business is required. Complete confirmation below.
